  - A. **Comply with the Rules and Regulations of New Hampshire Supreme Court Rule 53, including any amendments thereto, and meet the standards set forth in Rule 53.4 and 53.5.**
  - B. **Supply the NHMCLE Board with notice of each program presented and the attendance list and be willing to supply materials from seminars, if requested.**
  - C. **Provide all attorneys in attendance with a Certificate of Attendance showing the Sponsor's name, the date, location and length of each program.**
  - D. **Furnish to the NHMCLE Board within thirty (30) days after each CLE activity the Report of Course or Activity by Annual NHMCLE Sponsor Form and the \$35.00 fee for courses held in New Hampshire.**  
 NOTE: Submission of the \$35.00 activity or course fee is required of all sponsors of approved activities presented in New Hampshire **including satellite, teleconference and audio/video programs, and on-line and CD Rom courses** except when approved activities are offered without charge to attendees. Programs held outside of New Hampshire are not subject to the \$35.00 fee.
  - E. **Conduct all CLE activities substantially as advertised and represented to the NHMCLE Board subject to emergency substitutions and withdrawals.**
  - F. **Allow in-person observation of all CLE activities by members and staff of the NHMCLE Board without charge.**
- 14. The sponsor acknowledges that its Annual Sponsor status may be withdrawn and CLE credits not granted to course participants for violations of the Rules and Regulations or for failure to comply with the agreements and representations contained in this application. Annual Sponsor status must be renewed annually.
- 15. Approval as an NHMCLE Annual Sponsor allows the sponsor to advertise all programs held within the accreditation year as preapproved for NHMCLE credit in accordance with Rule 53.5.
